• Photocopy of your baccalaureate certificate, or equivalent (if the original certificate is not in Spanish, English or French, you also need to provide a sworn translation in Catalan, Spanish or English). If you have not yet completed your baccalaureate course, or equivalent, when you apply to pre-enrol, you should submit a statement declaring that you will be in possession of this certificate before the start of the 2019/2020 academic year.

• Photocopy of your academic transcript for your baccalaureate course, or equivalent, including all your grades for the past two years (if the original academic transcript is not in Spanish, English or French, you also need to provide a sworn translation in Catalan, Spanish or English).

• Certificate accrediting Level B2 proficiency (as per the Council of Europe's Common European Framework of Reference for Languages) in the language(s) required for the course in question. If you have taken your baccalaureate, or equivalent, in the language(s) required for the course, you do not have to provide this certificate. If you are not yet able to accredit Level B2 proficiency in the language(s) required for the course when you apply to pre-enrol, you should submit a statement declaring that you will be in possession of this certificate before the start of the 2019/2020 academic year.

For Spanish, we accept DELE (Diploma de Español como Lengua Extranjera) certificates awarded by the Instituto Cervantes (further information: http://dele.cervantes.es/). For Catalan, we accept certificates at "Nivell intermedi" or "Nivell superior" awarded by the Direcció General de Política Lingüística (further information: https://www.llull.cat/english/aprendre_catala/certificates_intro.cfm). For English, we accept Cambridge certificates at FCE level or higher, an IELTS score of 6.0 or higher and a TOEFL (iBT) score of 87 or higher, among others. • Optionally, your scores on an internationally recognised higher-education admission test (SAT, ACT or similar).
